Dear Rutland Parish/Town Council,

Hopefully you attended the parish liaison meeting on 5th September. If you did, you'll have discussed and approved the partnership proposed between Rutland County Council (RCC) and Leicestershire and Rutland Association of Local Councils (LRALC).

If you didn't attend, briefly, RCC and LRALC will work together to relaunch RCC's parish liaison events using a new format. The new structure will bring six meetings each year, a sizeable resource commitment by RCC which reflects its desire to build and strengthen its working relationship with its parishes. One of LRALC's roles is to work with Rutland parishes to help identify and bring forward issues from its member councils in Rutland for these meetings. Parishes will be able to submit items for consideration directly to LRALC.

The plan for the meetings to be held is below, with provisional dates identified in each case.

Clerks' Operational Meetings

These meetings are specifically for clerks. The agenda will focus on operational matters which impact on parish/town councils.
